VILLAGE CONSULTATIVE BODY

REGENT OF SOUTH BOLAANG MONGONDOW,

Considering : that in order to implement the provisions of Article 65 paragraph (2) of Law Number 6 of 2014 concerning Villages as has been amended several times, most recently by Law Number 3 of 2024 concerning the Second Amendment to Law Number 6 of 2014 concerning Villages, it is necessary to stipulate a Regional Regulation concerning the Village Consultative Body;

Observing : 1. Article 18 paragraph (6) of the 1945 Constitution of the Unitary State of the Republic of Indonesia;  
2. Law Number 30 of 2008 concerning the Formation of Bolaang Mongondow Selatan Regency in North Sulawesi Province (State Gazette of the Republic of Indonesia of 2008 Number 103, Supplement to the State Gazette of the Republic of Indonesia Number 4876);  
3. Law Number 23 of 2014 concerning Regional Government (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to the State Gazette of the Republic of Indonesia Number 5587) as has been amended several times, most recently by Law Number 6 of 2023 concerning the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 concerning Job Creation to become Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);  
4. Law Number 6 of 2014 concerning Villages (State Gazette of the Republic of Indonesia of 2014 Number 7, Supplement to the State Gazette of the Republic of Indonesia Number 5495) as has been amended several times, most recently by Law Number 3 of 2024 concerning the Second Amendment to Law Number 6 of 2014 concerning Villages (State Gazette of the Republic of Indonesia of 2024 Number 77, Supplement to the State Gazette of the Republic of Indonesia Number 6914);  
5. Minister of Home Affairs Regulation Number 110 of 2016 concerning Village Consultative Body (State News of the Republic of Indonesia of 2017 Number 89);

To Issue : THE REGULATION CONCERNING THE VILLAGE CONSULTATIVE BODY.

## CHAPTER I GENERAL PROVISIONS

### Article 1

In this Regional Regulation what is meant by:

1. Village Consultative Body, hereinafter abbreviated as BPD, is an institution that carries out governmental functions whose members are representatives of the Village population based on territorial representation and are democratically established.
2. Region is Bolaang Mongondow Selatan Regency.
3. Regent is the Regent of Bolaang Mongondow Selatan.
4. Regional Government is the Regent as the element organizing regional government who leads the implementation of governmental affairs which are the authority of the autonomous Region..
5. Camat is the leader and coordinator of government administration in the Sub-district working area who, in the execution of his duties, receives delegation of governmental authority from the Regent to handle part of the autonomous regional affairs and to organize general governmental tasks.
6. Village is a legal community unit that has territorial boundaries authorized to regulate and manage governmental affairs, local community interests based on community initiative, original rights, and/or traditional rights recognized and respected in the system of government of the Unitary State of the Republic of Indonesia.
7. Village Government is the organization of governmental affairs and local community interests within the system of government of the Unitary State of the Republic of Indonesia.
8. Sangadi is the Village Government official who has the authority, duties, and obligations to administer the household of his Village and to carry out tasks from the central government, the Government of North Sulawesi Province, and the Regional Government.
9. Village Government is the Sangadi assisted by the Village Apparatus as the organizing element of the Village Government.
10. Village Apparatus is the staff element that assists the Sangadi in policy formulation and coordination housed in the Village Secretariat, and the supporting element for the Sangadi's tasks in policy implementation housed in the form of technical implementers and territorial elements.

11. Village Level Sangadi Election Committee, hereinafter referred to as the Election Committee, is a committee formed by the BPD to organize the Sangadi Election process.
12. Sangadi Election is the execution of people's sovereignty in the Village for the purpose of electing a Sangadi which is direct, general, free, secret, honest, and fair.
13. Sangadi Candidate is a prospective Sangadi candidate who has been designated by the Election Committee as a candidate eligible to be elected as Sangadi.
14. Elected Sangadi Candidate is the Sangadi Candidate who receives the most votes in the implementation of the Sangadi Election.
15. Village Revenue and Expenditure Budget, hereinafter abbreviated as APB Desa, is the annual financial plan of the Village Government.

## CHAPTER II

### MEMBERSHIP OF THE VILLAGE CONSULTATIVE BODY

#### Part One

##### Requirements for BPD Candidate Members

###### Article 2

The requirements for BPD candidate members are:

- a. to be devoted to Almighty God;
- b. to uphold and practice Pancasila, implement the 1945 Constitution of the Unitary State of the Republic of Indonesia, and maintain the integrity of the Unitary State of the Republic of Indonesia and Bhinneka Tunggal Ika;
- c. to be at least 20 (twenty) years old or have been married;
- d. to have at least a junior high school education or equivalent;
- e. not to be a Village Apparatus;
- f. to be willing to be nominated as a BPD member;
- g. to be a representative of the Village population elected democratically; and
- h. to reside in the electoral area.

#### Part Two

##### Filling BPD Membership

###### Article 3

- (1) BPD members are representatives of the Village population based on territorial representation, whose filling is done democratically, taking into account 30% (thirty percent) representation of women.
- (2) The number of BPD members as referred to in paragraph (1) is set at an odd number, a minimum of 5 (five) persons and a maximum of 9 (nine) persons.
- (3) The determination of the number of BPD members as referred to in paragraph (2) takes into account the population size and the Village's financial capacity.
- (4) The determination of the number of BPD members by considering the population size as referred to in paragraph (3), shall be carried out under the following provisions:

- a. for Villages with a population up to 1,600 (One Thousand Six Hundred) people, the BPD members number 5 (five) persons;
- b. for Villages with a population from 1,601 (One Thousand Six Hundred and One) people up to 2,400 (Two Thousand Four Hundred) people, the BPD members number a maximum of 7 (seven) persons; and
- c. for Villages with a population of more than 2,401 (Two Thousand Four Hundred and One) people, the BPD members number a maximum of 9 (nine) persons.

#### Article 4

The filling of BPD membership is carried out through:

- a. filling based on territorial representation; and
- b. filling based on women's representation.

#### Article 5

- (1) The filling of BPD membership based on territorial representation as referred to in Article 4 letter a is carried out to elect BPD candidate members from the element of territorial representatives in the Village.
- (2) The number of BPD members from each territory as referred to in paragraph (1) is determined proportionally by considering the population size.
- (3) The number of BPD electoral territories is determined by considering the number of hamlets (dusun) and elements of community diversity.
- (4) The number of electoral territories as referred to in paragraph (1) is stipulated by the Sangadi before the committee is formed.

#### Article 6

- (1) The filling of BPD membership based on women's representation as referred to in Article 4 letter b is carried out to elect at least 30% (thirty percent) of women who have the ability to voice and champion women's interests as BPD members.
- (2) The women's representative as referred to in paragraph (1) is a female Village resident who meets the requirements for BPD candidate members.
- (3) The election of the women's representative element as referred to in paragraph (1) is carried out by female Village residents who have the right to vote.

#### Article 7

- (1) The filling of BPD membership as referred to in Article 3 paragraph (1) is carried out by a committee stipulated by a Decree of the Sangadi.
- (2) In the event that the Sangadi does not stipulate the committee as referred to in paragraph (1), the Camat shall stipulate the committee for the filling of BPD membership.
- (3) The committee as referred to in paragraph (1) and paragraph (2) shall consist of a maximum of 11 (eleven) persons, consisting of Village Apparatus elements, a maximum of 3 (three) persons, and community elements, a maximum of 8 (eight) persons.

(4) The community element as referred to in paragraph (3) is a representative from the territory.

#### Article 8

- (1) The committee as referred to in Article 7 paragraph (1) conducts the screening and selection of prospective BPD candidate members within a period of 6 (six) months before the BPD membership term ends.
- (2) Prospective BPD candidate members who meet the requirements are stipulated as BPD candidate members.
- (3) The election of BPD candidate members as referred to in paragraph (2) is carried out no later than 3 (three) months before the BPD membership term ends.

#### Article 9

- (1) The filling of BPD membership is carried out through a direct election process or representative deliberation.
- (2) In the event that the mechanism for filling BPD membership is stipulated through a direct election process as referred to in paragraph (1), the committee shall organize a direct election of BPD candidate members by the community element who has the right to vote.
- (3) In the event that the mechanism for filling BPD membership is stipulated through a representative deliberation process as referred to in paragraph (1), the BPD candidate members are elected in a representative deliberation process by the element of community representatives who have the right to vote.
- (4) The elected BPD candidate member is the BPD candidate member with the most votes.

#### Article 10

- (1) The elected BPD candidate member shall be submitted by the committee to the Sangadi no later than 7 (seven) days since the elected BPD candidate member was stipulated by the committee.
- (2) The elected BPD candidate member as referred to in paragraph (1) shall be submitted by the Sangadi to the Regent through the Camat no later than 7 (seven) days since the receipt of the election results from the filling committee to be inaugurated by the Regent.

### Part Three

#### Inauguration of BPD Members

#### Article 11

- (1) The inauguration of BPD members is stipulated by a decree of the Regent no later than 30 (thirty) days since the receipt of the report on the results of the BPD member election from the Sangadi.
- (2) The Regent's decree as referred to in paragraph (1) shall become effective from the date of the BPD member's oath and pledge taking.
- (3) The BPD member's oath/pledge taking shall be led by the Regent or an appointed official no later than 30 (thirty) days

since the issuance of the Regent's decree concerning the inauguration of BPD members.

#### Article 12

- (1) At the time of the oath/pledge taking as referred to in Article 11 paragraph (3), the BPD member concerned shall be accompanied by a religious leader according to their respective religion and/or belief.
- (2) The oath/pledge taking as referred to in paragraph (1) shall be carried out in the presence of the concerned Village community.
- (3) After the oath/pledge taking as referred to in paragraph (1), it shall be followed by the signing of the oath/pledge taking minutes.
- (4) Further provisions concerning the procedure for the BPD member's oath/pledge taking shall be regulated by a Regent's Regulation.

#### Article 13

BPD members who have carried out the oath/pledge taking as referred to in Article 12 paragraph (3) shall attend initial term of office training carried out by the Regional Government.

### Part Four

#### Term of BPD Membership

#### Article 14

- (1) The term of BPD membership is 8 (eight) years commencing from the date of the oath/pledge taking and can be re-elected to the same position.
- (2) BPD members as referred to in paragraph (1) may be elected for a membership term of a maximum of 2 (two) times consecutively or non-consecutively.

### Part Five

#### Dismissal of BPD Members

#### Article 15

- (1) A BPD member ceases to hold office due to:
  - a. death;
  - b. resignation; or
  - c. dismissal.
- (2) A BPD member shall be dismissed as referred to in paragraph (1) letter c, in the event of:
  - a. the expiration of the membership term;
  - b. inability to perform duties continuously or permanent impediment for 6 (six) consecutive months without explanation;
  - c. no longer meeting the requirements as a BPD member;
  - d. failure to carry out obligations;
  - e. violation of the prohibition as a BPD member;

- f. violation of the oath/pledge of office and BPD code of ethics;
- g. being found guilty based on a final and binding court decision for committing a criminal offense with a sentence of imprisonment of 5 (five) years or more;
- h. failure to attend plenary meetings and/or other BPD meetings which are their duties and obligations 6 (six) consecutive times without a valid reason;
- i. a change in the Village status to a sub-district (kelurahan), the merging of 2 (two) or more Villages into 1 (one) new Village, the splitting or elimination of a Village;
- j. residing outside the original electoral territory; and/or
- k. being designated as a Sangadi Candidate.

#### Article 16

- (1) The dismissal of a BPD member is proposed by the BPD leadership based on the results of the BPD deliberation to the Regent through the Sangadi.
- (2) The Sangadi shall follow up on the proposal for the dismissal of the BPD member to the Regent through the Camat no later than 7 (seven) days since the receipt of the dismissal proposal.
- (3) The Camat shall follow up on the proposal for the dismissal of the BPD member to the Regent no later than 7 (seven) days since the receipt of the dismissal proposal.
- (4) The Regent shall inaugurate the dismissal of the BPD member no later than 30 (thirty) days since the receipt of the proposal for the dismissal of the BPD member.
- (5) The inauguration of the dismissal of a BPD member as referred to in paragraph (3) is stipulated by a Regent's decree.

#### Part Six

##### Temporary Dismissal of BPD Members

#### Article 17

- (1) A BPD member shall be temporarily dismissed by the Regent after being designated as a suspect in a criminal act of corruption, terrorism, treason, and/or a criminal act against state security.
- (2) In the event that a temporarily dismissed BPD member holds the position of BPD leadership, it shall be followed by dismissal as a BPD leader.
- (3) In the event that a BPD leader is dismissed as referred to in paragraph (2), the other BPD leaders shall lead the by-election meeting for the BPD replacement leader.

#### Part Seven

##### Filling of BPD Inter-time Members

#### Article 18

- (1) In the event that a BPD member resigns or is dismissed before the end of their term of office, an inter-time filling of BPD membership shall be held.
- (2) The inter-time filling of BPD membership as referred to in paragraph (1) shall be filled by the BPD candidate member with

the next sequence number based on the BPD member election results.

- (3) In the event that the BPD candidate member with the next sequence number as referred to in paragraph (2) dies, resigns, or no longer meets the requirements as a BPD candidate member, they shall be replaced by the BPD candidate member with the next sequence number.
- (4) The term of office of the inter-time BPD member shall continue the remainder of the term of office of the BPD member they replace.
- (5) The term of office as referred to in paragraph (4) shall be counted as 1 (one) period.

#### Article 19

- (1) No later than 7 (seven) days since the inter-time dismissed BPD member is stipulated, the Sangadi shall submit the proposed name of the replacement BPD member to the Regent through the Camat.
- (2) No later than 7 (seven) days since the receipt of the proposal for the inter-time dismissed BPD member as referred to in paragraph (1), the Camat shall submit the proposed name of the replacement BPD member to the Regent.
- (3) The Regent shall inaugurate the prospective replacement BPD member as a BPD member with a Regent's decree no later than 30 (thirty) days since the submission of the BPD member replacement proposal from the Sangadi.
- (4) The inauguration of the BPD member as referred to in paragraph (2) shall become effective from the oath/pledge taking and shall be guided by the Regent or an appointed official.
- (5) At the time of the oath/pledge taking as referred to in paragraph (4), the BPD member concerned shall be accompanied by a religious leader according to their respective religion and/or belief.
- (6) The oath/pledge taking as referred to in paragraph (4) shall be carried out in the presence of the concerned Village community.
- (7) After the oath/pledge taking as referred to in paragraph (4), it shall be followed by the signing of the oath/pledge taking minutes.

#### Article 20

- (1) The inter-time replacement of a BPD member shall not be carried out if the remaining term of office of the replaced BPD member is less than 6 (six) months.
- (2) The BPD membership as referred to in paragraph (1) shall remain vacant until the end of the BPD member's term of office.

## Part Eight

### Prohibitions for BPD Members

#### Article 21

BPD members are prohibited from:

- a. harming public interest, unsettling a group of Village community, and discriminating against Village residents or community groups;
- b. engaging in corruption, collusion, and nepotism, accepting money, goods, and/or services from other parties that may influence decisions or actions to be taken;
- c. abusing authority;
- d. violating the oath/pledge of office;
- e. concurrently holding office as Sangadi and/or Village Apparatus;
- f. concurrently holding office as a member of the House of Representatives of the Republic of Indonesia, the Regional Representative Council of the Republic of Indonesia, other Regional House of Representatives or the Regional House of Representatives, and other positions stipulated in statutory regulations;
- g. acting as a Village project implementer;
- h. becoming an administrator of a political party; and/or
- i. becoming a member and/or administrator of a prohibited organization.

## CHAPTER III

### INSTITUTIONAL STRUCTURE OF THE VILLAGE CONSULTATIVE BODY

#### Article 22

- (1) The institutional structure of the BPD consists of:
  - a. leadership; and
  - b. divisions.
- (2) The BPD leadership as referred to in paragraph (1) letter a consists of:
  - a. 1 (one) chairman;
  - b. 1 (one) vice chairman; and
  - c. 1 (one) secretary.
- (3) The divisions as referred to in paragraph (1) letter b consist of:
  - a. division for Village Government administration and community development; and
  - b. division for Village development and Village community empowerment.
- (4) The divisions as referred to in paragraph (3) are led by a division chairman.
- (5) The BPD leadership and division chairmen concurrently serve as BPD members.

#### Article 23

To support the implementation of the BPD institutional tasks, 1 (one) administrative staff for BPD shall be appointed.

## Article 24

- (1) The BPD leadership and division chairmen as referred to in Article 22 paragraph (1) are elected from and by the BPD members directly in a specially convened BPD meeting.
- (2) The meeting for the election of BPD leadership and division chairmen as referred to in paragraph (1) shall be led for the first time by the oldest member and assisted by the youngest member.
- (3) The election meeting as referred to in paragraph (2) shall be held no later than 3 (three) days calculated from the date of the oath/pledge taking.
- (4) Subsequent election meetings for leadership and/or division chairmen due to the leadership and/or division chairmen ceasing to hold office, shall be led by the chairman or other BPD leaders based on the agreement of the BPD leadership.

## Article 25

- (1) The elected leadership and division chairmen as referred to in Article 24 paragraph (1) are stipulated by a BPD decree.
- (2) The BPD decree as referred to in paragraph (1) shall become effective after obtaining the endorsement of the Camat on behalf of the Regent.

# CHAPTER IV

## FUNCTIONS AND DUTIES OF THE BPD

### Part One

#### General

## Article 26

The BPD has the following functions:

- a. discussing and agreeing on Draft Village Regulations together with the Sangadi;
- b. accommodating and channeling the aspirations of the Village community; and
- c. supervising the performance of the Sangadi.

## Article 27

The BPD has the following duties:

- a. gathering community aspirations;
- b. accommodating community aspirations;
- c. managing community aspirations;
- d. channeling community aspirations;
- e. holding BPD deliberations;
- f. holding Village deliberations;
- g. forming the Election Committee;
- h. holding a special Village deliberation for the inter-time Sangadi Election;
- i. discussing and agreeing on Draft Village Regulations together with the Sangadi;
- j. supervising the performance of the Sangadi;
- k. evaluating the accountability report on the Village Government administration;

1. creating a harmonious working relationship with the Village Government and other Village institutions; and
- m. carrying out other duties regulated by statutory regulations.

**Part Two**  
**Gathering Community Aspirations**

**Article 28**

- (1) The BPD shall gather community aspirations.
- (2) The gathering of aspirations as referred to in paragraph (1) may be carried out directly with Village institutions and community, including groups of poor people, people with special needs, women, and marginalized groups.
- (3) The gathering of aspirations shall be carried out based on a BPD deliberation decision outlined in the BPD work agenda.
- (4) The implementation of gathering aspirations as referred to in paragraph (1) shall use an activity guide that minimally includes the purpose, objective, target, time, and description of the activity.
- (5) The results of gathering Village community aspirations shall be submitted in the BPD deliberation.

**Part Three**  
**Accommodating Community Aspirations**

**Article 29**

- (1) The implementation of activities to accommodate community aspirations shall be carried out at the BPD secretariat.
- (2) Community aspirations as referred to in paragraph (1) shall be administered and submitted in the BPD deliberation.

**Part Four**  
**Management of Community Aspirations**

**Article 30**

- (1) The BPD shall manage Village community aspirations through administration and formulation of aspirations.
- (2) The administration of aspirations as referred to in paragraph (1) is based on divisions, which include the divisions of government, development, community development, and Village community empowerment.
- (3) The formulation of aspirations as referred to in paragraph (1) is carried out by analyzing and formulating Village community aspirations to be submitted to the Village Head in order to realize good governance and the welfare of the Village community.

**Part Five**  
**Channeling Community Aspirations**

**Article 31**

- (1) The BPD shall channel community aspirations in verbal and/or written form.

- (2) The channeling of community aspirations in verbal form as referred to in paragraph (1) shall be carried out through the presentation of community aspirations by the BPD in a BPD deliberation attended by the Sangadi.
- (3) The channeling of community aspirations in written form as referred to in paragraph (1) shall be carried out through the submission of aspirations via letter in the context of providing input for the Village Government administration, requesting information from the Sangadi, or submitting a draft Village Regulation originating from the BPD's proposal.

## Part Six

### Holding BPD Deliberations

#### Article 32

- (1) BPD deliberations shall be held to produce a BPD decision on strategic matters.
- (2) Strategic matters as referred to in paragraph (1) include deliberations on discussing and agreeing on a Draft Village Regulation, evaluating the accountability report on the Village Government administration, stipulating the BPD rules of procedure, and proposing the dismissal of a BPD member.
- (3) The BPD shall hold BPD deliberations with the following mechanisms:
  - a. the BPD deliberation is led by the BPD leadership;
  - b. the BPD deliberation is declared valid if attended by at least 2/3 (two-thirds) of the total number of BPD members;
  - c. decision-making is carried out by deliberation to reach a consensus;
  - d. in the event that a consensus is not reached, decision-making is carried out by voting;
  - e. the voting as referred to in letter d is declared valid if approved by at least 1/2 (one-half) plus 1 (one) of the total number of BPD members present; and
  - f. the results of the BPD deliberation shall be stipulated by a BPD decree and accompanied by the deliberation minutes made by the BPD secretary.

## Part Seven

### Holding Village Deliberations

#### Article 33

- (1) Village deliberations shall be organized by the BPD and facilitated by the Village Government.
- (2) A Village deliberation is a consultation forum attended by the BPD, the Village Government, and Village community elements to deliberate on strategic matters in the Village Government administration.
- (3) Strategic matters as referred to in paragraph (2) include:
  - a. Village arrangement;
  - b. Village planning;
  - c. Village cooperation;
  - d. planned investment entering the Village;
  - e. establishment of a Village-Owned Enterprise;

- f. addition and release of Village assets; and
- g. extraordinary occurrences.

(4) The community elements as referred to in paragraph (2) consist of:

- a. traditional leaders;
- b. religious leaders;
- c. community leaders;
- d. education leaders;
- e. representatives of farmer groups;
- f. representatives of fisherman groups;
- g. representatives of artisan groups;
- h. representatives of women's groups;
- i. representatives of child protection and advocacy groups; and
- j. representatives of underprivileged community groups.

(5) In addition to the community elements as referred to in paragraph (4), Village deliberations may involve other community elements in accordance with the community's socio-cultural conditions.

(6) Village deliberations as referred to in paragraph (1) shall be financed by the APB Desa.

## Part Eight

### Formation of the Election Committee

#### Article 34

- (1) BPD membentuk Panitia Pemilihan serentak dan Panitia Pemilihan antarwaktu.
- (2) Ketentuan mengenai pembentukan Pantia Pemilihan sebagaimana dimaksud pada ayat (1) ditetapkan dengan Keputusan BPD.

#### Pasal 35

- (1) The Election Committee as referred to in Article 34 paragraph (1) consists of Village Apparatus and community elements.
- (2) The number of Election Committee members shall be adjusted to the workload and financial capacity.
- (3) The Election Committee as referred to in paragraph (1) is responsible to the BPD.
- (4) In the event that a member of the Election Committee fails to carry out their duties and obligations, they may be dismissed by a BPD decree.

## Part Nine

### Holding a Special Village

#### Deliberation for the Inter-time Sangadi Election

#### Article 36

- (1) The BPD shall hold a special Village deliberation for the inter-time Sangadi Election.
- (2) The holding of the Village deliberation as referred to in paragraph (1) is carried out to ratify the Sangadi

Candidates submitted by the Election Committee and to elect and ratify the Elected Sangadi Candidate.

(3) The Village deliberation forum shall submit the Elected Sangadi Candidate as referred to in paragraph (2) to the Election Committee to be submitted to the BPD.

### Article 37

The BPD shall submit the Elected Sangadi Candidate as referred to in Article 36 paragraph (3) to the Regent no later than 7 (seven) days since the receipt of the report on the Sangadi Election results from the Election Committee.

## Part Ten

### Discussion and Agreement of the Draft Village Regulation

### Article 38

- (1) The BPD and the Sangadi shall discuss and agree on the Draft Village Regulation proposed by the BPD and/or the Sangadi.
- (2) The discussion of the Draft Village Regulation as referred to in paragraph (1) shall be organized by the BPD in a BPD deliberation.
- (3) The Draft Village Regulation proposed by the Sangadi as referred to in paragraph (1) shall first be discussed in an internal BPD deliberation no later than 10 (ten) working days calculated from the time the Draft Village Regulation is received by the BPD.
- (4) The implementation of the discussion of the Draft Village Regulation as referred to in paragraph (1) between the BPD and the Sangadi shall be carried out for the first time no later than 30 (thirty) days since the internal BPD deliberation.
- (5) Every discussion of a Draft Village Regulation shall be recorded in the deliberation minutes.

### Article 39

- (1) In the event that the discussion of the Draft Village Regulation between the BPD and the Sangadi does not reach an agreement, the joint deliberation shall still take a decision accompanied by a note of the unresolved issues.
- (2) The Draft Village Regulation as referred to in paragraph (1) may be submitted by the Sangadi to the Regent through the Camat accompanied by a note of the unresolved issues no later than 7 (seven) days since the last discussion deliberation to obtain evaluation and guidance.
- (3) The follow-up to the evaluation and guidance as referred to in paragraph (2) may take the form of:
  - a. termination of the discussion; or
  - b. guidance for the follow-up discussion and agreement of the Draft Village Regulation.
- (4) The follow-up discussion and agreement as referred to in paragraph (3) letter b may be attended by the Camat or another official appointed by the Regent.

**Part Eleven**  
**Supervision of the Sangadi's Performance**

**Article 40**

- (1) The BPD shall supervise the performance of the Sangadi.
- (2) The implementation of supervision as referred to in paragraph (1) shall be carried out through:
  - a. planning of Village Government activities;
  - b. implementation of activities; and
  - c. reporting of Village Government administration.
- (3) The form of BPD supervision as referred to in paragraph (1) is monitoring and evaluation.

**Article 41**

The results of the supervision of the Sangadi's performance as referred to in Article 40 paragraph (1) shall be part of the BPD performance report.

**Part Twelve**  
**Evaluation of the Accountability**  
**Report on Village Government Administration**

**Article 42**

- (1) The BPD shall evaluate the accountability report on the Village Government administration.
- (2) The evaluation of the report as referred to in paragraph (1) is an evaluation of the Sangadi's performance during 1 (one) fiscal year.
- (3) The implementation of the evaluation as referred to in paragraph (1) shall be carried out based on the principles of democratic, responsive, transparency, accountability, and objective.
- (4) The evaluation of the implementation of the Sangadi's duties as referred to in paragraph (1) includes:
  - a. achievement of the implementation of the Village medium-term development plan, Village Government work plan, and APB Desa;
  - b. achievement of the implementation of assignments from the Central Government, the Provincial Government of North Sulawesi, and the Regional Government;
  - c. achievement of compliance with the implementation of duties in accordance with statutory regulations; and
  - d. Sangadi's achievements.
- (5) The implementation of the evaluation as referred to in paragraph (1) shall be part of the BPD performance report.

**Article 43**

- (1) The BPD shall evaluate the accountability report on the Village Government administration no later than 10 (ten) working days since the accountability report on the Village Government administration is received.

- (2) Based on the results of the evaluation as referred to in paragraph (1), the BPD may:
  - a. make notes on the Sangadi's performance;
  - b. request information or data;
  - c. state an opinion; and
  - d. provide input for the preparation of Village deliberation materials.
- (3) In the event that the Sangadi does not fulfill the BPD's request as referred to in paragraph (2) letter b, the BPD shall continue the process of resolving the evaluation of the accountability report on the Village Government administration by providing notes on the Sangadi's performance.
- (4) The evaluation of the accountability report on the Village Government administration as referred to in paragraph (1) shall be part of the BPD performance report.

**Part Thirteen**  
**Creating a Harmonious Working Relationship**  
**with the Village Government and Other Village Institutionsa**

**Article 44**

- (1) In order to create a harmonious working relationship with the Village Government and other Village institutions, the BPD may propose to the Sangadi to form a communication forum among Village institutions.
- (2) The forum as referred to in paragraph (1) shall consist of the chairman/head elements of the established Village institutions.
- (3) The forum as referred to in paragraph (2) shall be stipulated by a Sangadi decree.
- (4) The duty of the forum as referred to in paragraph (1) is to agree on and resolve various current issues in the village.

**CHAPTER V**  
**RIGHTS, OBLIGATIONS, AND**  
**AUTHORITIES OF THE VILLAGE CONSULTATIVE BODY**

**Part One**  
**Rights of the BPD**

**Article 45**

The BPD has the right to:

- a. supervise and request information about the Village Government administration from the Village Government;
- b. state an opinion on the Village Government administration, Village development implementation, Village community development, and Village community empowerment; and
- c. obtain operational costs for the execution of its duties and functions from the APB Desa.

## Article 46

- (1) The BPD shall supervise through monitoring and evaluating the execution of the Sangadi's duties.
- (2) The monitoring and evaluation as referred to in paragraph (1) are related to the planning, implementation, and reporting of the Village Government administration.

## Article 47

- (1) The BPD shall use the right to state an opinion based on a BPD decision.
- (2) The statement of opinion as referred to in paragraph (1) is a conclusion from the careful and objective assessment of the Village Government administration.
- (3) The assessment as referred to in paragraph (2) is carried out through discussion and in-depth study of an object of the Village Government administration conducted in a BPD deliberation.
- (4) The BPD decision as referred to in paragraph (1) is based on the results of the BPD deliberation.

## Article 48

- (1) The BPD shall obtain operational costs sourced from the APB Desa.
- (2) The operational costs as referred to in paragraph (1) shall be used to support the execution of the BPD's functions and duties.
- (3) The allocation of operational costs as referred to in paragraph (2) shall consider the components of operational needs and the Village's financial capacity.

## Part Two Rights of BPD Members

### Article 49

- (1) BPD members have the right to:
  - a. propose a draft Village Regulation;
  - b. raise questions;
  - c. convey proposals and/or opinions;
  - d. elect and be elected;
  - e. receive allowances from the APB Desa sourced from the Village fund allocation;
  - f. receive social security in the field of health and employment; and
  - g. receive a one-time severance allowance at the end of the term of office in accordance with the Village's Financial Capacity regulated by statutory regulations.
- (2) The rights of BPD members as referred to in paragraph (1) letters a to d shall be exercised in the BPD deliberation.
- (3) In addition to the rights as referred to in paragraph (1), BPD members have the right to:
  - a. obtain capacity building through education and training, socialization, technical guidance, and field visits carried out domestically; and

- b. receive awards for BPD leaders and members who achieve excellence in accordance with statutory regulations.
- (4) Provisions regarding the amount of allowance for BPD members from the APB Desa sourced from the Village fund allocation as referred to in paragraph (1) letter e shall be regulated in a Regent's Regulation.

#### Article 50

- (1) The allowance as referred to in Article 49 paragraph (1) letter e includes allowances for the execution of duties and functions and other allowances.
- (2) The allowance for the execution of duties and functions as referred to in paragraph (1) is a position allowance.
- (3) Other allowances as referred to in paragraph (1) are performance allowances.

#### Article 51

- (1) The position allowance for BPD members as referred to in Article 50 paragraph (2) is provided based on the member's position within the BPD institution.
- (2) The performance allowance as referred to in Article 50 paragraph (3) may be provided in the event of an increase in workload.
- (3) The performance allowance as referred to in paragraph (2) is sourced from the Village's original revenue.
- (4) The amount of the BPD allowance as referred to in paragraph (1) and paragraph (2) shall be stipulated by the Regent.

### Part Three

#### Obligations of BPD Members

#### Article 52

BPD members are obliged to:

- a. uphold and practice Pancasila, implement the 1945 Constitution of the Unitary State of the Republic of Indonesia, and maintain the integrity of the Unitary State of the Republic of Indonesia and Bhinneka Tunggal Ika;
- b. implement gender-just democratic life in the Village Government administration;
- c. prioritize public interest over personal, group, and/or factional interests;
- d. respect the social and cultural values and customs of the Village community;
- e. maintain norms and ethics in the working relationship with the Village Government institution and other Village institutions; and
- f. safeguard community aspirations, maintain the authority and stability of the Village Government administration, and pioneer the Village Government administration based on good governance.

## Part Four

### Authorities of the BPD

#### Article 53

The BPD is authorized to:

- a. hold meetings with the community to obtain aspirations;
- b. convey community aspirations to the Village Government verbally and in writing;
- c. propose a Draft Village Regulation that is within its authority;
- d. carry out monitoring and evaluation of the Sangadi's performance;
- e. request information about the Village Government administration from the Village Government;
- f. state an opinion on the Village Government administration, Village development implementation, Village community development, and Village community empowerment;
- g. safeguard community aspirations, maintain the authority and stability of the Village Government administration, and pioneer the Village Government administration based on good governance;
- h. stipulate the BPD rules of procedure;
- i. submit a report on the results of incidental supervision to the Regent through the Camat;
- j. prepare and submit a written proposal for the BPD operational cost plan to the Sangadi to be allocated in the draft APB Desa;
- k. manage the BPD operational costs;
- l. propose the formation of a communication forum among Village institutions to the Sangadi; and
- m. conduct visits to the community in the context of monitoring and evaluating the Village Government administration.

#### CHAPTER VI

### WORKING RELATIONSHIP OF THE VILLAGE CONSULTATIVE BODY WITH OTHER INSTITUTIONS IN THE VILLAGE

#### Article 54

- (1) The working relationship between the BPD and the Village Government is partnership-based.
- (2) The partnership relationship as referred to in paragraph (1) is carried out through coordination and supervision in the Village Government administration and Village development.
- (3) The working relationship between the BPD and Village community institutions and Village traditional institutions is consultative.

#### CHAPTER VII

### CAPACITY BUILDING FOR MEMBERS OF THE VILLAGE CONSULTATIVE BODY

#### Article 55

- (1) The Regional Government shall carry out activities for the capacity building of BPD members.

- (2) Capacity building as referred to in paragraph (1) shall be carried out through the following activities:
  - a. education and training;
  - b. socialization;
  - c. technical guidance; and/or
  - d. field visits carried out domestically.
- (3) Funding for BPD member capacity building activities as referred to in paragraph (1) and paragraph (2) may be sourced from:
  - a. the regional revenue and expenditure budget;
  - b. the APB Desa; and/or
  - c. other legitimate and non-binding sources in accordance with statutory regulations.

## CHAPTER VIII CLOSING PROVISIONS

### Article 56

This Regional Regulation shall come into force on the date of its promulgation.

For public knowledge, the promulgation of this Regional Regulation is ordered by placement in the Regional Gazette of Bolaang Mongondow Selatan Regency.

**I. GENERAL**

The BPD has a strategic position and function in the Village Government administration. The success of the Village Government administration also depends on the BPD's contribution in carrying out its role. Therefore, the filling of BPD members is expected to be based on the aspirations of the community, taking into account the element of territorial representation and carried out democratically. If this process can be fulfilled, it is expected that the administration of government and the implementation of village development can provide real benefits for the progress and improvement of the welfare of the village community. In addition to matters related to the process of filling BPD membership, this Regional Regulation also regulates several other aspects, namely the institutional structure of the BPD, the rights, obligations, and authorities of the BPD, the working relationship of the BPD with other institutions in the Village, and the capacity building of BPD members. The regulation related to the aforementioned substance is mandated by the provisions in the Minister of Home Affairs Regulation Number 110 of 2016 concerning the Village Consultative Body.
